Kings District Policing Report

Kings District Employees

Our new District Commander for Kings, Inspector William (Bill) Collier, arrived in July. This will be the last Police Advisory Board meeting for me (S/Sgt. Ed Nugent) as I am departing for West Hants District (Windsor Detachment) on September 22. My replacement as Senior Operations NCO for Kings District will be S/Sgt. Dan Archibald, currently the District Commander in Queens County. S/Sgt. Archibald is in the process of transferring here and should be in place in the coming weeks.

Forty general duty constables police Kings District as first responders. These officers are supervised by eight corporals, two sergeants, and one staff sergeant.

Kings East School Safety Resource Officer Cst. Jennifer Britton left us for a new job in Halifax District at the end of the last school year. A replacement will be named for her soon. The Kings West School Safety Resource Officer has been off duty for an extended period. Kings District managers are hopeful that at least one SSRO position will be filled early in the new school year.

A corporal supervisor heads up both our General Investigation Section (GIS) and our Street Crime Enforcement Unit (SCEU). GIS consists of two constable investigators, while SCEU is an integrated team consisting of two Kings District RCMP constables and one constable from the Kentville Police Service.

Kings District has ten Detachment Services Assistants who perform administrative functions at the three Kings District offices.





Annual Performance Plan

The Kings District Annual Performance Plan runs from April 1st to March 31st annually. Objectives for the 2025-2026 Annual Performance Plan have yet to be finalized but here are some numbers from the first quarter of 2025/2026:

- **Safe Roads and Safe Highways in Nova Scotia**
During this quarter (April to June inclusive) Kings District members charged **23** people with impaired driving or refusing to provide a breath sample, more than double the 10 impaired charges last quarter. Members also issued **5** roadside suspensions for drug and/or alcohol use, wrote **308** summary offence tickets (vs 146 last time) and **152** (vs 102) warnings, and conducted **31** check stops. Check stops were another big jump from the 19 conducted last quarter. All in all, great work was done in traffic enforcement to kick off fiscal 2025-2026.
- **Crime Prevention – Property Crime**
Crime prevention and enforcement efforts continue across the County of Kings. Members continue to conduct physical checks on offenders/accused parties who are on court ordered curfews or house arrest, with the goal of preventing recidivism. Kings Members conducted **113** individual curfew checks during the reporting period, up from last quarter's total of 90.
- **Community Engagement – Municipal/Indigenous governments & Stakeholder groups**
Kings District's dedicated First Nations Policing officer has been off-duty for several months. In his absence Kings district senior managers are staying in touch with the Chiefs and Councils of both local First Nations to discuss issues of priority for the community. Kings managers and other members continue to meet and correspond with many other stakeholder groups through the County as well.

Calls for Service

From April 1st to June 30th, Kings District (excepting Wolfville Detachment) responded to 4,165 service calls involving a total of 4,961 investigated offences. Of the latter, 3353 occurred in New Minas Detachment's area and 1,608 were in Kingston's area. Significant Investigations


And now for the interesting files. Here are details on a couple of the investigations Kings members undertook in the first quarter of the fiscal year:

Explosives and firearms seized on South Mountain File 2025-514892

On April 19th, 2025 Kings District RCMP responded to a weapons complaint at a residence in a rural area south of Gaspereau village. The complainant stated there were firearms and possibly gun powder in a residence belonging to a man who was reportedly out of the province at the time. Kings members confirmed numerous firearms and possible bomb making equipment at the scene, which they secured while awaiting assistance from specialized RCMP sections including the Explosives Disposal Unit (EDU). A search warrant was obtained for the buildings and large rural property. The property was searched slowly and safely under the careful guidance of the EDU, and well over a hundred exhibits were seized. The adult male suspect was located and arrested in Prince Edward Island by local authorities at the request of the “H” Division RCMP. He remains in custody awaiting trial for numerous criminal charges including various firearms and weapons offences as well as making/possessing explosives.

Masked assailant sexually assaults youth in Canning File 2025-784797

On the afternoon of June 6th, 2025 New Minas RCMP responded to a report that a female youth in her teens had been sexually assaulted behind the hockey arena in Canning. The victim reported she was walking on a trail when she was attacked from behind by a male wearing a ski mask. The suspect knocked the victim to the ground and assaulted her both physically and sexually. The young woman kept screaming and fighting back and the suspect eventually disengaged and fled. Given that this incident occurred on a sunny afternoon in a high-traffic area shortly after school let out, Kings District members treated this investigation as an absolute highest priority. All available members attended the scene immediately and searched extensively with the assistance of a Police Dog Services canine. The suspect was not located but evidence was found and seized at the scene. After an exhaustive investigation led by the Kings District General Investigations Section with great support from specialized sections within the “H” Division



RCMP, a male youth suspect was identified and arrested on June 18. The youth is currently before the courts facing charges of assault, sexual assault, and disguising himself with intent to commit a criminal offence. I am very proud of the work our members did on this disturbing and difficult investigation; starting out with a completely unknown and disguised suspect, they built a case and made an arrest in just 12 days.
