## **Kings District Employees**

Our District Commander for Kings is Inspector Bill Collier.

A Staff Sergeant is the Senior Operations NCO for Kings.

### **Organizational Chart Changes for Kings District 2025/2026:**

- **4 Watch System - Consisting of 4 Sergeants leading each watch (The Increase of 2 Sergeants is Pending)**
- **Each Watch has 12 members with 2 being Corporal Team Leads**
- **Wolfville has designated 2 members per watch, Kingston 4 and New Minas 6, however resource float as needed**

General Investigation Section (GIS) and our Street Crime Enforcement Unit (SCEU).

- **GIS - 1 Corporal and 2 Constable investigators out of the New Minas Detachment**
- **SCEU - Integrated with Kentville - 2 RCMP and 1 KPS Constable**

School Safety Resource Officer (SSRO)

- 1 Constable for East (not yet filled)
- 1 Constable for West

The Kings District has 10 Detachment Services Assistants who perform administrative functions at the 3 Kings District offices. This includes the Wolfville Municipal Detachment Assistant, Jaimelee Chambers.

Shortages:

- 2 long term Off Duty Sick Constables
  - 2 Vacant Constable Positions awaiting staffing actions
  - 1 Corporal in Kingston Watch 4 awaiting transfer in March
  - 2 Sergeants awaiting selection
- \*\*\*Kings District Currently has 3 constables under Recruit Field Training and 2 more arriving in March\*\*\*

## **Files of Significance**

### **TOWN OF WOLFVILLE**

- **IPV** - There have been 36 incidences of Domestic Violence in which charges consisting of Assault, Assault with a Weapon, Sexual Assault and Breach court Orders have been laid
- **Impaired Driving** - There has been 26 reported incidences of impaired driving with 10 charges
- **Mental Health Act** - There have been 101 calls for service in the town of Wolfville related to the Mental Health Act.
- **Theft of Motor Vehicle** - There has been 10 thefts of motor vehicles reported, 1 clear by charge and only 1 case still remains open

### **KINGS DISTRICT**

- **Warrant Execution in Canning** - December 18th a search warrant was executed by General Duty and SCEU officers leading to seizure of \$50K worth of stolen property and a .22 caliber rifle
- **Warrant Execution in New Minas** - January 18th a search warrant was executed by GIS and General Duty leading to seizure of fentanyl, cocaine, methamphetamine, percocets and hydromorphone
- **Joint Rescue of Cape Split Lost Hikers** - JRCC Cormorant CFB Greenwood successful retrieval of lost hikers
- **Cannabis Dispensary Inspection** - Welton Landing - General Duty conducted a Cannabis enforcement inspection under the Cannabis Control Act on the Gaspereau Lake Treaty Truck-House located at 3129 Hwy 12 in Welton Landing, NS.
