## RECOMMENDATION

That Municipal Council send a letter to the Nova Scotia Federation of Municipalities (NSFM) requesting the Grand Council flag to be displayed at NSFM conferences and events, where municipal flags are flown.

## INTENT

For Municipal Council to recommend that Municipal Council write to the NSFM regarding displaying the Grand Council flag at NSFM events.

## DISCUSSION

At the 2025 NSFM Spring Conference, staff presented on the work undertaken by the Municipality of the County of Kings towards equity, inclusion, and belonging. Knowing the Municipality of the County of Kings is a leader among Nova Scotia municipalities in advancing reconciliation and diverse representation, a Mi'kmaq attendee from another municipality spoke about their unsuccessful efforts to have the Mi'kmaq Grand Council flag displayed at NSFM proceedings and asked for advocacy on the matter.

The Mi'kmaq Grand Council flag, also called the Santé Mawiomi (*Sahn-tay Mah-wee-oh-mee*) flag, is a symbol of the Mi'kmaq Nation. The Province of Nova Scotia has recognized it as an official flag of sovereignty, treating it with precedence immediately following official flags. The Mi'kmaq Grand Council is the traditional political structure of the peoples living in Mi'kma'ki. Within this governing structure, each of the seven Districts has a District Chief elected by the tribal Chiefs from that district, with one District Chief appointed as Grand Chief.

The Grand Council flag dates back to around 1900, when it was first raised in Listuguj (*Lis-tu-guch*), Quebec. The flag gained prominence following the Supreme Court's *Marshall* Decision in 1999, which affirmed treaty rights and established the flag as a symbol for exercising traditional governance and fishing rights. The flag's design carries deep symbolic meaning: its white field represents creation's purity, while the red cross signifies humanity and the four directions. The red sun and moon represent day and night respectively, and together these elements symbolize traditional governance, culture, and spiritual beliefs across Mi'kma'ki. Today, while the flag is widely flown during Mi'kmaq History Month and on significant dates like Treaty Day, permanent installations at various institutions have become important signs of reconciliation, acknowledgement of Indigenous presence, and cultural revitalization. Given that the Nova Scotia Federation of Municipalities facilitates advocacy, collaboration, and education among its member communities, displaying the Grand Council flag at conferences, and events alongside municipal flags directly supports these organizational goals and demonstrates meaningful commitment to reconciliation.



# Request for Decision

On January 5, 2026, staff presented the matter to the Diversity Kings County Committee. Following the presentation, the Committee passed a motion recommending Municipal Council write a letter to NSFM asking consideration be given to including the Grand Council flag wherever municipal flags are displayed.

To the Executive Committee:

The Municipality of the County of Kings is committed to reconciliation and recognizing the presence of Mi'kmaq Peoples across Mi'kma'ki. This letter is a formal request that the Nova Scotia Federation of Municipalities (NSFM) commit to displaying the Mi'kmaq Grand Council flag at conferences and events of the NSFM, where municipal flags are flown.

This initiative aligns with the mission of NSFM to facilitate strategic advocacy, collaboration, and education. Representation of the Grand Council flag promotes advocacy for Mi'kmaq self-determination and the rights guaranteed under the Peace and Friendship Treaties. It demonstrates collaboration by presenting the Mi'kmaq Nation's flag alongside other government flags and provides opportunities to educate about the flag's significance. Symbolizing traditional governance, culture, and spiritual beliefs across Mi'kma'ki, the flag was first raised in Listuguj, QC around 1900. Permanent representation at institutions is a meaningful step towards reconciliation, acknowledgement of Indigenous presence, and cultural revitalization.

A [report](#) prepared for the Federation of Canadian Municipalities suggests strategies for taking action to support the rights of Indigenous Peoples using a United National Declaration on the Rights of Indigenous Peoples (UNDRIP) framework. UNDRIP recognizes that Indigenous Peoples have the right to freely determine their political status and development and their future within the territories in which they traditionally lived. Displaying the Mi'kmaq Grand Council flag implements key UNDRIP framework actions including:

- 1) Recognizing Indigenous rights-holders who hold ancestral, treaty, traditional, Indigenous and other legal and constitutionally protected rights and titles to the lands and waters on which municipalities are located.
- 2) Respecting and honouring Indigenous legal systems and creating space for their expression within municipal spheres.
- 3) Engaging with political organizations, institutions, and entities that Indigenous Peoples and communities themselves identify as legitimately representing their interests and memberships.




## APPENDIX B: Image and Symbolism of Flag

White	Wape'k	<i>Wa-beeg</i>	Creation's purity
Red Cross	Mekwe'k Klujjiewey	<i>Meg-wayg Kloo-joo-way</i>	Humanity and the Four Directions
Sun	Na'ku'set	<i>Nah-goo-set</i>	Day
Moon	Tepknuset	<i>Dep-goo-noo-set</i>	Night

The Grand Council Flag is meant to fly vertically as shown here, so the cross is upright with the crescent moon and sun (star) on the top of the flag.

If the flag is flown horizontally, the moon and sun should be on the Left side, with the sun on the top of the flag.

## RECOMMENDATION

That Municipal Council proclaim February 2026 as “African Heritage Month” in the Municipality of the County of Kings.

## INTENT

To present the proclamation request for adoption in accordance with the Municipality’s Proclamation Policy COMM-02-003.

## DISCUSSION

Black History Month has been recognized in Canada since 1950, with Nova Scotia playing a leading role in its promotion and celebration. In 1985, the first official opening night of Black History Month was held at the North Branch Library, followed in 1987 by the inaugural meeting of the Black History Month Association and the first province-wide celebration. In recognition of Nova Scotia’s more than 400 years of history and the enduring contributions of people of African descent, the observance was renamed African Heritage Month in 1996. February was officially proclaimed Black History Month by the Canadian Senate in 2008.

In 2004, the Department of African Nova Scotian Affairs (ANSA) held the inaugural reading of the African Heritage Month Proclamation at Province House. Since that time, ANSA has worked to expand awareness and engagement across the Province by partnering with organizations to form the African Heritage Month Information Network. This network includes representatives from each region and collaborates annually to develop the provincial theme, promote events and municipal proclamations, and produce an educational poster for the month. I am honoured to serve as a member of this provincial network.

Within the Municipality of the County of Kings are two historic African Nova Scotian communities: Gibson Woods and Pine Woods. Gibson Woods is named after George Gibson, a Black Loyalist who purchased forty acres of land for forty pounds in 1802. Pine Woods, now known as Aldershot, was founded by sisters Dinah Powell and Chloe Lanzey after they fled enslavement by Benjamin Belcher.

Proclaiming African Heritage Month in the Municipality of the County of Kings aligns with the Implementation Plan of the Municipality’s Strategy for Belonging, particularly actions guided by the African Diaspora, Anti-Black Racism, and Reparations lenses. The proclamation also strengthens relationships between the Municipality and diverse communities, while building public trust, awareness, and engagement by honouring over four centuries of contributions from the African Diaspora—

encompassing historic Black communities such as Gibson Woods and Pine Woods, as well as newcomers to the region.

Finally, the proclamation advances the shared vision of the Municipality of the County of Kings as “*a community of communities where all people belong.*”

**APPENDIX B: African Heritage Month Proclamation 2026**

WHEREAS, February is recognized internationally as Black History Month – a time to acknowledge and honour the history, culture, resilience, and contributions of people of African descent; and

WHEREAS, in recognition of the enduring legacy of Black and African Nova Scotian peoples for over 400 years, Black History Month was renamed African Heritage Month in the Province of Nova Scotia in 1996; and

WHEREAS, the Municipality of the County of Kings is home to the historic African Nova Scotian communities of Gibson Woods and Pine Woods (Aldershot), whose histories reflect strength and perseverance; and

WHEREAS, African Heritage Month provides an opportunity to acknowledge the impacts of systemic racism and anti-black racism, while affirming the importance of equity, inclusion and belonging for all residents; and

WHEREAS, proclaiming African Heritage Month aligns with the Municipality's Strategy for Belonging which establishes an African Diaspora, Anti-Black Racism, and Reparations lens to guide our commitments; and

WHEREAS, this year's theme is Strength in Unity: Moving Forward with Purpose, Prosperity, Power and Progress;

THEREFORE, BE IT RESOLVED that I, Mayor Corkum, on behalf of the Council of the Municipality of the County of Kings, do hereby proclaim the month of February 2026 as African Heritage Month in the Municipality of the County of Kings and encourage all residents to learn about, reflect upon, and celebrate the histories, culture and contributions of African Nova Scotians and people of African descent.

Diversity Kings began with a presentation on 4 Levels of Racism. We had a deeply thoughtful discussion on when children are affected by racism. Members shared their own personal reflections and lived experiences. I am so very grateful for this safe space.

A community member is concerned that the Valley Waste Calendar does not have the diversity holidays included. Staff are looking into it.

The Diversity Committee (I abstained because I am on the Board of the NSFM) has voted to request a letter be written, to the NSFM, for the NSFM to display a flag respecting the Indigenous peoples of the Province at NSFM events.

We reviewed our workplan and are excited for upcoming training. I did request that staff consider how the unhoused may be helped by our Committee. It has become quite a hot topic, so much so that Minister Lohr is having a public engagement session on January 22<sup>nd</sup>, 7pm, at the Kentville Fire Hall.

In lieu of the February meeting, the Diversity Committee has agreed to prioritize working and attending the African Heritage Month Launch event on February 2<sup>nd</sup>. Last year it was well attended from people all over the Province. It is especially amazing to see the involvement of our youth sharing their heritage.

Diversity Kings will meet again on March 2<sup>nd</sup>.
