Motions from the April 16 Special Council meeting:

Municipal Council passed motions approving the following actions:

 Appoint Grant Thornton LLP as Municipal Auditor for the financial period that ended March 31, 2024.

Motions from the April 2 Municipal Council meeting:

Municipal Council passed motions approving the following actions:

- Give Initial Consideration to, and hold a Public Hearing regarding, entering into a Development Agreement to permit Tourist Commercial Uses at 100 Alton Road in East Dalhousie.
- Give Initial Consideration to, and hold a Public Hearing regarding, entering into a Development Agreement to permit 12 tourist cabins at 1459 Forest Hill Road.
- Give Initial Consideration to, and hold a Public Hearing regarding, entering into a Development Agreement to allow the development of a campground at 5734 Highway 358, Scots Bay.
- Give Initial Consideration to, and hold a Public Hearing regarding, entering into a Development
 Agreement to allow 16 additional residential units within four approved multi-unit dwellings on
 a property (PID 55046056) on Aldershot Road in North Kentville.
- Give Second Reading to the application to rezone properties at 496/498 and 500/502 Mosher
 Street in Kingston from Residential One Unit (R1) to the Residential Mixed Density (R3) Zone.

- Give Final Consideration to entering into a Development Agreement to allow the addition of a restaurant, event venue and expanded commercial area within an existing building at 1441 Church Street in Port Williams.
- Give Final Consideration regarding changes to an approved Development Agreement for a vacant parcel of land in the southeast quadrant of J Jordan Road and Summer Street in Canning.
- Proclaim May 5-11, 2024 "Heart Failure Awareness Week" in the Municipality of the County of Kings."
- Adopt changes to Policy FIN-05-003: Fees, as described in the April 2, 2024, Council agenda. (Changes to sewer charges and streetlight fees)
- Adopt changes to Policy FIN-05-024: Property Tax Sales as described in the April 2, 2024, Council
 agenda. (Added a line stating that the property tax sale for fiscal year 2023-24 will happen in
 June 2024).
- Adopt changes to Policy FIN-05-026 Tax Exemptions for Non-Profit Organizations as described in the April 2, 2024, Council agenda. (Made changes to property list included in the policy)
- Award Contract #24-06 "Animal Control Enforcement Services" to the Nova Scotia SPCA for five years.
