### Motions from the May 6 Council meeting

**Council passed motions approving the following actions:**

- Give Second Reading to the application to rezone 1.94 acres of 7015 Highway 1 in Coldbrook from the Heavy Industrial (M2) Zone to the Light Industrial Commercial (M1) Zone.
- Give Second Reading to the application to rezone a parcel of vacant land on Ernst Drive in Aylesford from the Residential One and Two Unit (R2) Zone to the Residential Mixed Density (R3) Zone.
- Give First Reading to, and hold a Public Hearing regarding, the application to change the Land Use By-law text and map to allow the expansion of an existing day care facility at 1733 Highway 1 in Auburn.
- Give initial consideration to, and hold a Public Hearing regarding, entering into a Development Agreement to legalize the three tourist cabins at 1143 West Halls Harbour Road in Halls Harbour.
- Give First Reading to, and hold a Public Hearing regarding, the application to rezone 683 Central Avenue in Greenwood from the General Commercial (C1) Zone to the Mixed Commercial Residential (C3) Zone.
- Give initial consideration to, and hold a Public Hearing regarding, entering into a Development Agreement to allow a Tourist Commercial Use within an existing building at 1081 Cape Split Road in Scots Bay.
- Proclaim May 2025 to be "Lyme Disease Awareness Month" in the Municipality of the County of Kings.

- Proclaim May 18-24, 2025 to be "VON Week" in the Municipality of the County of Kings.
- Proclaim June 12, 2025 to be "Cole Wittenberg Day" in the Municipality of the County of Kings.
- Change Policy FIN-05-002: Council and Committee Remuneration as attached to the May 6, 2025, Council agenda.
- Adopt Policy DBS-03-006: Storm Water Management, as attached to the May 6, 2025, Council agenda.
- Authorize the Chief Administrative Officer to send letters to Canadian Air Division Headquarters to express support of a flyby by Canadian Armed Forces aircraft, as low as 500 feet, and to grant permission for the Canadian Armed Forces to land a helicopter at the Family Day event at 5 CDSG Detachment Aldershot on June 14, 2025.
- Approve the Guarantee of the Village of Canning's Debenture issue (45-A-1) in the amount of \$550,000 in relation to the purchase of a new fire truck for the Canning and District Volunteer Fire Department.
- Approve the Municipality of the County of Kings' proportional share of the guarantee associated with Valley Regional Solid Waste-Resource Management Authority's Debenture 45-A-1.
- Receive the Regional Sewer Update presentation from May 6, 2025, for information.
