3.1 Evaluation of Tenders

i. Selection of the successful bidder shall be based on the following point system:

	Category	Points
1.	Model Year	10
2.	Warranty	15
3.	Fuel Consumption	30
4.	Purchase Price	45

- 1. **Model Year** will be scored 10 out of 10 for 2022 model year service vehicles, 5 out of 10 for 2021 model year service vehicles, and 0 out of 10 for 2020 (or older) model year service vehicles.
- 2. Warranty will be scored according to the following criteria:

Comprehensive Warranty:

- 6 points for 5 year/99,000km or better
- 3 points for 3 year/59,000km
- 0 points for anything less

Power Train Warranty:

- 6 points for 5 year/99,000km or better

- 3 points for 3 year/99,000km
- 0 points for anything less

Corrosion:

- 1.5 points for 5 year or better
- 0 points for anything less

Major emissions:

- 1.5 points for 5 year/79,000km or better
- 0 points for anything less

3. Fuel Consumption:

Fuel Consumption Score = TFE/MFE x FEW

Where: TFE = Tenderer's Fuel Economy (in Mi/imp.gal)

MFE = Maximum Fuel Economy of all tenderers (in Mi/imp.gal)

FEW = Fuel Economy Weighting (30 points)

4. Purchase Price:

Price Score = LTP/TP x PW

Where: LTP = Lowest Tender Price of all tenderers

TP = Tenderer's Price

PW = Price Weighting (45 points)

ii. Municipal Staff will evaluate and score all tenders received as per the criteria set in 3.1 (i). The bidder who meets the minimum requirements as set in the Tender Documents and receives the highest score will be recommended to the Chief Administrative Officer for award.

3.2 Rejection of Tenders

- i. The Municipality reserves the right to suspend or cancel this tender at any time for any reason without penalty.
- ii. The Municipality reserves the right to reject any and all bids or accept any bid or part thereof and may award all or a portion of the work to one or more contractors.
- iii. The Municipality reserves the right to waive any formalities or informalities, or to reject any or all tenders based on the Tenderer's lack of proven experience, performance on similar projects, or the suitability of proceeding with the execution of the work
- iv. In the event that a number of suppliers submits bids in substantially the same amount, the Municipality may, at its discretion, call upon those Tenderers to submit further bids.
- v. No term or condition shall be implied, based upon any industry or trade practice or custom, any practice or policy of the Municipality or otherwise, which are inconsistent with the provisions contained herein.
