This Addendum forms part of the "Contract Documents" and modifies or clarifies the original "Contract Documents" for the above referenced procurement call.

Proposals must be received before 2:00 pm Atlantic Standard Time Thursday February 9, 2023 ("Submission Deadline") in order to be considered.

1. **Question:** Project timelines. Existing laydown adjacent to Cell 1 is allotted for dewatering of Cell 2 in the awarded contract. Additional area will need to be constructed for dewatering process of Cell 1. Where is this?

Response: Two potential areas are noted in the aerial image below, the area noted on the left of the image would require fence reinstatement. Other areas near Cell 1 may also be considered.

The RFP timeline also states completion at May 30, 2023. Does dewatered sludge have to be removed from site by completion date?


Response: Dewatered sludge may remain at the site until December 15, 2023. It may be disposed of incrementally over time, provided this is completed prior to December 15, 2023, if this option would present cost savings to the Municipality.

3. **Question:** Can the municipality consider paying based on bone dry metric tonne unit rates rather than *m*<sup>3</sup>?

Response: Amend Supplementary Specifications, Section 01 22 00 Measurement and Payment; Section 2.0 Schedule 'A' Items to change the Unit of Measure from *Lump Sum (L.S.)* to *Bone Dry Tonne (BDT)*.

4. **Question:** *Projected <quantities> (800m<sup>3</sup>) is not a large qty. Can the municipality define the specific area of Cell 1 that will require dredging on a marked up drawing?* 

Response: The areas circled in blue in the image below are the primary areas requiring sludge removal, with particular attention to the corners of Cell #1.
